In consideration of being granted the opportunity to participate, I hereby agree to release and hold harmless the The Maker Spot at the North Richland Hills Public Library and the City of North Richland Hills, its employees, volunteers, committees and boards, from and against any and all liability, loss, damages, claims, or actions (including costs and attorney's fees) for bodily injury and/or property damage, to the extent permissible by law.

I hereby assume all of the risks of participating in any/all activities associated with The Maker Spot at the North Richland Hills Library, including by way of example and not limitation, any risks that may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained, or controlled by them, or because of their possible liability without fault.

I, hereby for myself, on behalf of my heirs, successors, and assigns, in consideration of being permitted to use tools and equipment, agree to release and indemnify and hold harmless and defend The Maker Spot at the North Richland Hills Library, its employees, volunteers, committees and boards, from any and all liability, loss, claims, and demands, actions, or cause of action for the death or injury to any persons and for any property damage suffered or incurred by any person which arises or may arise or be occasioned in any way from the Maker or possession of tools, technology, equipment or supplies I am using in The Maker Spot at the North Richland Hills Library. Any available insurance of the Maker's shall be primary and The Maker Spot at the North Richland Hills Library shall be Non Contributory.

I hereby give permission to The Maker Spot at the North Richland Hills Library for emergency transportation and/or treatment in the event of illness or injury and this release extends to any liability arising in connection with such transportation and/or treatment. I hereby accept responsibility for the payment of any emergency transportation and/or treatment. I further certify that I am in good physical condition, and have no medical or physical conditions that would restrict my participation in this activity or program.

I acknowledge that The Maker Spot at North Richland Hills Library and its employees, volunteers, committees and boards are not responsible for the errors, omissions, acts, or failures to act of any party or entity conducting a specific activity on their behalf.

I understand while participating in this activity, I may be photographed. I agree to allow my photo, video, or film likeness to be used for any legitimate purpose by The Maker Spot at North Richland Hills Library and its employees, volunteers, committees and boards or its assignees.
